## 2025 FORD BRONCO® WILD FUND SWEEPSTAKES OFFICIAL RULES

The 2025 Ford Bronco® Wild Fund Sweepstakes ("Sweepstakes") is sponsored by Ford Motor Company, 16800 Executive Plaza Drive, Dearborn MI 48126 ("Sponsor").

- 1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on March 27, 2025 at 12:00:01 A.M., ET and ends on November 30, 2025 at 11:59:59 P.M., ET ("Sweepstakes Period").
- 2. ELIGIBILITY: This Sweepstakes is open only to legal residents of the fifty (50) United States and District of Columbia, who are at least eighteen (18) years old at the time of entry and have a valid driver's license. Employees, officers and directors of Sponsor, Ford dealership(s), Xperience Communications, Mercury Promotions & Fulfillment ("Administrator"), and any of their respective owners, parent companies, affiliates, directors, subsidiaries, representatives, advertising, Sweepstakes and production agencies or agents (collectively, the "Sweepstakes Entities"), as well as their immediate family members (defined as including spouse; biological, adoptive, and/or step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) and persons living in the same household (whether related or not) of any of the above are not eligible to enter or win. Void where prohibited by law. All federal, state, and local laws apply.

Participation by an individual ("Entrant") constitutes Entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning the prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winner may be required to provide proof of identification and eligibility as required by Sponsor. For purposes of the Sweepstakes, an Entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of registration. Entrants will not be allowed to change their physical address or e-mail address on a submitted registration. Use of any automated system or any like methods to participate in the Sweepstakes is prohibited and will result in disqualification of any Entrant attempting such use.

- 3. HOW TO ENTER THE SWEEPSTAKES: During the Sweepstakes Period, an Entrant must attend one of Sponsor's events (an "Event") and enter by either (i) visiting a booth/Event area and using a laptop/tablet available at the booth/Event area to access the "Registration Page" or (b) scan a QR Code on the signage or QR Code on a Bronco vehicle at an Event which will direct the Entrant's mobile device to the Registration Page. While on the Registration Page, the Entrant must complete first and last name, street address (P.O. Boxes are not allowed), city, state, ZIP Code, date of birth, valid e-mail address, answer a number of survey questions, and agree to these Official Rules. Upon successful completion and submission of the registration information, the Entrant will receive one (1) entry into the Sweepstakes. Limit one (1) entry per Entrant/household/email address for the entire Sweepstakes Period, irrespective of the method of entry.
- 4. RANDOM DRAWING: On or about Wednesday, December 3, 2025, the Administrator will randomly select one (1) potential winner from among all eligible entries received during the Sweepstakes Period. The winner is considered a potential winner pending verification of their eligibility and compliance with these Official Rules. The Sponsor's, and its representative's, decisions are final and binding on all matters relating to this Sweepstakes.

## 5. PRIZE, APPROXIMATE RETAIL VALUE, AND ODDS OF WINNING:

A. Prize (1): The prize includes: (i) one (1) 2025 Bronco Big Bend (Big Bend® Mid Package (222A), 2.3L EcoBoost® I-4 Engine Drivetrain 4x4 with Part Time Selectable Engagement, Big Bend® Mid Package (222A), 10-Speed Automatic Transmission with a Manufacturer's Suggested Retail Price ("MSRP") of \$50,000 (the "Bronco"); and (ii) \$15,000, in a check made payable to the confirmed winner so that the winner can pay the costs as set forth in Rule 5B (collectively, the "Prize"). The Approximate Retail Value ("ARV") of the Prize is up to \$65,000. Note that if the Bronco selected is less than \$50,000, the difference

between the actual price and the MSRP will not be paid to the winner, but the IRS form set forth below will reflect the actual Prize value.

- B. Specific Conditions of the Prize. The actual Prize features/options will be determined by Sponsor in its sole and absolute discretion. The Prize is awarded in "As-Is" and "Where-Is" condition, subject to any express limited warranty provided by Sponsor. Any vehicle upgrades, aftermarket additions, options or other elements beyond the model details provided in these Official Rules will not be available to the winner, in Sponsor's sole and absolute discretion. Once the Winner is confirmed and he/she is given the dealership/contact then he/she has 30 days to confirm details of the selected Bronco from dealer stock or order a Bronco. The Prize will be delivered to the Winner through an authorized Sponsor dealership close to the winner's residence, selected by Sponsor, in its sole and absolute discretion. No other delivery option will be available. Subject to availability, the Bronco will be delivered approximately 120 days from final verification of the winner's eligibility (as further described in Rule 5 and 6 above). The Winner is solely responsible for taking delivery. If the Winner refuses delivery, the Prize may be forfeited, at Sponsor's sole and absolute discretion. The Winner is responsible for all taxes and expenses, including but not limited to sales tax, luxury tax, destination charges, registration, title and license fees, insurance, and all other costs incurred in claiming, registering or using the vehicle. The Winner must present his/her valid U.S. driver's license and provide satisfactory proof of liability insurance prior to Prize delivery.
- C. General Conditions on the Prize: All other costs, fees and expenses not expressly set forth in these Official Rules are not included in the Prize. The Prize is non-transferrable and non-substitutable, except by Sponsor in its sole discretion. Should the Prize become unavailable for any reason, Sponsor reserves the right to substitute the Prize for one of equal or greater value to the Winner, in its sole discretion. All taxes and other expenses, costs, or fees associated with the acceptance and/or use of the Prize are the sole responsibility of the winner. If the Prize is unclaimed within a reasonable time after notification from Sponsor, as determined by Sponsor in its sole discretion, it will be forfeited, and, time permitting, an alternate Winner may be selected from the remaining eligible Entries at Sponsor's sole discretion. No more than one (1) Prize will be awarded in this Sweepstakes.
- **D. Odds of Winning:** The odds of winning the Prize depend on the number of eligible entries received during the entire Sweepstakes Period.
- 6. WINNER NOTIFICATION AND VERIFICATION: The potential winner will be notified by telephone or email and will have seven (7) business days from the date of the telephone call and email to respond to qualify for the Prize. Failure to respond within the time permitted in these Official Rules will be viewed by the Sponsor as declining the Prize and relinquishing all rights and involvement in the Sweepstakes and the Prize.

The potential winner is subject to verification of eligibility and compliance with these Official Rules. The potential winner will be required to provide his/her mailing address and to execute an Affidavit of Eligibility and Liability and Publicity Release (except where prohibited) and an IRS Form W-9 all via Adobe Sign, and to be returned by the date as set forth in the notification email or the Prize will be forfeited and, at Sponsor's discretion, an alternate winner will be selected from all remaining eligible entries.

If any potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept the Prize, or in the event that a winner fails to return any required paperwork within the allotted timeframe (if applicable), the Prize may be forfeited. If the Prize is forfeited for any reason, it may be awarded to an alternate potential winner, at the Sponsor's sole and absolute discretion. If Sponsor is unable to confirm any winner, the Prize may not be awarded. Sponsor will issue an IRS Form 1099-MISC to the winner. The Released Parties (defined in Rule 7) shall not be held responsible for any delays in awarding the Prize for any reason. The Prize will only be awarded to a verified winner.

7. LIMITATION OF LIABILITY: By participating in this Sweepstakes, each Entrant agrees that the Sweepstakes Entities and each of their respective representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each

their respective officers, directors, stockholders, employees, representatives, designees and agents ("Released Parties") are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; and (vii) any injury or damage, whether personal or property, to an Entrant or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting the Prize. Further, the Released Parties are not responsible for any unanswered or undeliverable winner notifications.

DISPUTES: THIS SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF MICHIGAN, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN WAYNE COUNTY, MICHIGAN. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN WAYNE COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR RELEASED PARTIES AND/OR ANY OTHER PARTY

SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR FROM THE END OF THE SWEEPSTAKES PERIOD, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.
